Binding Arbitration Process

The UIIA includes a Binding Arbitration Process for arbitration of claims relating to per diem/use charges & M & R. The purpose of the program is to provide an alternative method for resolving issues involving these types of invoices after all dispute resolution processes under the UIIA/EP Addenda have been exhausted.

Claims submitted under the Binding Arbitration Process must meet the criteria outlined under the Binding Arbitration Guidelines identified in Exhibit D in the UIIA and the claim must have occurred on or after August 1, 2008.

Note: Effective January 1, 2013, the filing fees for submission of claims under the Binding Arbitration process will be increased. There will be an Initiation Filing Fee of \$50.00 upon submission of the Notice of Intent Form and an Arbitration Filing Fee of \$250.00 once the claim is sent to the arbitration panel for review.
